BRIEF HISTORICAL DESCRIPTION:

This dwelling was erected before 1869 and by 1891, changed use to serve as an office. The building served as the Kane County Abstract Office when founded by Lynn C. Danforth in 1906. In January 1920, L. C. Danforth sold the property to Dr. Raymond G. and Mabel Scott, who turned the building 90 degrees and remodeled it as a rental residence with La Fox, Illinois contractor, T.W. Gibbs (14 January 1921 Geneva Republican). Per the sale agreement, the Kane County Abstract Co. was entitled to the property until June 1, 1920.
