#### **BRIEF HISTORICAL DESCRIPTION:**

In 1857, Benjamin Wilson leased land from his business partner, Joseph Cockroft (207 S. Fifth Street), for Disciples of Christ Church (the congregation previously met on the upper floor of 416 Hamilton Street). Cockroft sold the parcel to church trustees in 1859. The property reverted to Cockroft's heirs in 1893 when the church closed.

At some point in time (some historians suggest in the 1920s, but others say earlier or, perhaps, at the time of construction or shortly after), the exterior was finished with stucco, which was removed after 1945.

A garage was built for Axelina (Pearson) Anderson by George W. Wilson (contractor from Batavia) in July 1940 (Gen Rep). Axelina Anderson (1877-1964) married Charles Anderson in 1901 but divorced between 1920 and 1930. She and her daughter, Carla (who worked as a secretary at Mooseheart Children's Home), rented the house before 1930 but had purchased it by 1940. Carla Anderson sold the property in 1961 to Harding & Harding, Inc.

Harding & Harding, Inc. was a livestock insurance company, headed by Frank W. Harding, Jr. (1912-2002), who moved to Geneva in 1950 and acquired the corner of Fourth and Campbell streets in 1955.

Around 1961, the former Anderson home was converted into two apartments. According to unverified oral accounts, the exterior stucco was removed between 1970 and 1985, when the property was converted back to a single-family home. At that time, a limestone facade may have been installed on the east wall of the 1940 garage addition (believed to be the southernmost section of the present structure).

The property is notable for its association with one or more significant persons, architecture, and methods of construction—specifically locally-quarried limestone construction. The property is also notable for its association with community development—specifically the Early Settlement Period of Geneva (1837-1857)—and the establishment of the Disciples of Christ Community at Geneva.
