### **BRIEF HISTORICAL DESCRIPTION:**

Built for the two youngest daughters of Joseph H. and Teresa (Johnson) Mayborne, who were married in Kane County in December 1846. Their daughters were Teresa (1848-1882); Clara (1849-1900), who married Andrew P. Johnson in 1883; Grace (1852-1915); and Etta Irene (1857-1936), who was also known as "Minnie."

Joseph Hayward Mayborne (1820-1892) was born in England and arrived in Chicago in 1843 before settling in 1848 in Geneva, where he was a prominent, early attorney. His wife, Teresa Johnson (1827-1888), was the daughter of early Blackberry Township pioneer, Peter H. Johnson.

J. H. Mayborne built his family home in 1855 at 228 North Second Street. He served one term on the Kane County Board of Supervisors in 1848; one term as Geneva Village President (Mayor) in 1872; and four years as a state senator (1876-1880).

Grace and Etta, who never married, received the Fifth Street property in 1891 and moved to California around 1906 when Charles William (William C.) Johnson (1880-1959) and his wife, Minnie (Hanson), purchased the property. Grace Mayborne died in California, and Etta Mayborne returned to Geneva a few years later, occupying the family home at 228 North Second Street for the remainder of her life.

William and Minnie Johnson occupied the home with their sons Howard (b. 1909) and Floyd (b. 1916). William Johnson was the son of Swedish immigrants but had no apparent relation to the family of Grace and Etta's mother.

Married in 1904, William C. Johnson (1880-1959) worked 50 years as a freight claim agent for the C&NW Railroad (1906-1956); served as a City alderman in the early 20th century; was appointed City Treasurer (1913-1915); and was serving as First Ward Alderman (1949-1959) when he died.

William and Minnie Johnson obtained mortgages for improvements to the property in 1914, 1920, 1921, 1925, 1928, and 1940. The two-story addition at the southwest corner of the home was erected between 1912 and 1923. The Johnson family occupied the Fifth Street home until 1954.

The property is significant for its association with one or more significant persons and architecture—specifically the Colonial Revival style.
