### ADDITIONAL PROPERTY INFORMATION:

#### **BRIEF HISTORICAL DESCRIPTION:**

The property (S 1/2 Lots 8 & 9, Block 19) was sold by Gustav and Ellen Schutz to William H. and Ellen A. (Schutz) Smith in 1911; the mortgage was secured from the Geneva Building & Loan Association in December 1911. Ellen Smith was the daughter of Gustaf and Ellen Schutz, who lived immediately north (227 N. First).

The house is first visible in the 1912 Sanborn Fire Insurance map. It is a 2 story stucco house with a porch across the full front facade and another along the southern half of the rear facade. By 1923, the rear porch was enclosed and had moved about a quarter of the width of the house northwards. By 1930, the front porch was enclosed and there was a narrow garage on the north side of the lot. The property appeared the same in the 1945 map. Additional known residents of the site include W.A. Dahling (c 1934); Alice T Nelson (c 1956); Clarence Irwin (c 1958); and Angus and Emma Howington (c 1962-1981).

The property is notable for its association with architecture—specifically the American Foursquare style.
