ADDITIONAL PROPERTY INFORMATION:

BRIEF HISTORICAL DESCRIPTION:

Augustus and Betsey Conant acquired the property in 1843 but transferred it to Eben Conant in 1858. Eben Conant built an earlier house on this site connected to the limestone cottage to the south. The original house was moved to 18 Campbell Street between 1926 and 1928.

The earlier house was sold to Amanda Hight, the invalid sister of John Hight, who cared for her. Upon her death, the conjoined First Street houses (wood and stone houses) were transferred to John Hight in 1888. Later, the original house served as the home of John (1827-1905) and Sarah Hight (d. 1888). John Hight came to Geneva in 1854 and was a wagon-maker on the east side of the Fox River until the Civil War. Then, he became a pattern-maker and mechanic at the W. H. Howell Foundry before becoming a custodian for the Kane County Courthouse after 1891.

The 202 S. First Street property was deeded to the Hight daughters: Grace Hight Kenyon (died 1942) and Isabella Hight Nickerson (died 1921). Oliver C. "Ocie" and Grace (Hight) Kenyon sold the original house to Kate Raftery and built a new house at the 202 S. First Street property - completed in August 1928 (01 June 1928 and 03 August 1928 Geneva Republican).
